## Information Blocking and ONC Health IT Certification Dates

The ONC did an Extension of Compliance Dates and Timeframes in Response to the COVID-19 Public Health Emergency.

As of April 2020, this is our current understanding regarding communication regulations. PowerSoftMD Complies to all the currently required elements as of April, 2021.

### **April, 2021**

#### **1) § 170.401**

Information blocking, PowerSoftMD complies with. We sent you an email regarding it, you can refer to it again at: <https://powersoftmd.com> then support tab, then technical note # 59m

If a patient asks for their records, you can currently supply them via your portal or by exporting CCDAs to electronic readable media. PowerSoftMD blocks nothing.

### **December, 2022**

#### **2) § 170.404(b)(3), 170.315(g)(9), & 170.315(g)(10)**

Interoperability, which has multiple implementation dates; the first one is February, 2022.

# ONC Interim Final Rule

## Information Blocking and the ONC Health IT Certification Program: Extension of Compliance Dates and Timeframes in Response to the COVID-19 Public Health Emergency

ONC is taking steps to provide the health care system the flexibility to effectively respond to the public health threat posed by the spread of COVID-19. In review of the ONC Cures Act Final Rule, we determined the following updates are necessary through this interim final rule:

- Extending the compliance dates in the ONC Health IT Program (Program), including certain 2015 Edition health IT certification criteria and Condition and Maintenance of Certification requirements.
- Making changes to the Program by updating standards and clarifying regulatory text for specific certification criteria.
- Making technical corrections and clarifications.
